RESOLUTION TO ESTABLISH WARD BOUNDARIES TO REFLECT POPULATION CHANGES ACCORDING TO THE 2010 CENSUS OF POPULATION

WHEREAS, following the 2010 Census of Population municipalities are required to adjust the boundaries for those wards which have either gained or lost population and as a result no longer fit with the statutory population ranges; and

WHEREAS, municipalities are required to make a good faith effort to accommodate the tentative plan submitted by the county,

NOW, THEREFORE, BE IT RESOLVED, that the Town of Tilden, Chippewa County, Wisconsin does here by recognize the population of wards in their municipality as follow for the purposes of setting up voting districts.

| 2 | All land South of 70 th Street and 85 th Avenue East | 449 | Tilden Town to County Hwy F, North to 100 th Avenue, East to Hall County Hwy Q, North to 102 nd Avenue; East to 100 th Avenue, East to termini 130 th Street; except for Ward 3. |
| 3 | All land North of 70 th Avenue, East of 110 th Street, 213 | Tilden Town | South of County Hwy S and bordering the City of Hall Chippewa Falls. |

BE IT FURTHER RESOLVED, Ward 1 and 2 created above shall be represented by Supervisory District No. 7 and Ward 3 created above shall be represented by Supervisory District No. 13. See attached map.

BE IT FURTHER RESOLVED that the municipal clerk is required to forward a copy of the ward plan to the county within five (5) days after the municipality has enacted or adopted an ordinance or resolution creating wards in accordance with the tentative county supervisory redistricting plan.
